AGREEMENT REGARDING RISK OF HORSEBACK RIDING

On behalf of _____, I apply to ride horses provided by Tanque Verde Guest Ranch. I enter into this agreement in consideration for Tanque Verde Guest Ranch Giving _____ the right to ride its horses.

I understand that the horseback riding will expose _____ to above normal risks, some of which are beyond the control of Tanque Verde Guest Ranch and its employees. These risks include equipment failures, loss of control, collisions, obstacles, variations in terrain, and unexpected actions of the horses. These risks can cause injury to the rider in a variety of ways, including being thrown from the horse.

I represent that _____ has no health or physical condition that will interfere with horseback riding or cause _____ to be more susceptible to injury than the average person. I assume the risks associated with any such health or physical condition.

On behalf of _____, I agree to assume the risks of injuries suffered while riding horses provided by Tanque Verde Guest Ranch. I agree to release Tanque Verde Guest Ranch and its employees from liability for acts of simple negligence but not for acts of gross negligence.

Pursuant to A.R.S. 12-553(A)(2), the State of Arizona limits the liability of equine owners with regard to any injuries sustained while horseback riding. A copy of the entire law is available on request to the Tanque Verde Ranch. I am signing this release on behalf of myself, my children or wards as identified above.

I agree that if Tanque Verde Guest Ranch, its employee or agents are sued by anyone else for claims related to the conduct of my children or wards, I will indemnify Tanque Verde Guest Ranch and its employees or agents for all damages and costs.
